Kahn Ranch Addition (What to know before you go)

- Access to the 1,100 acre addition is by advance permit. Permits can be obtained at www.mprpd.org/permitapp.html or phone the Park District office 831-372-3196 ext. 108
- If driving in via Hitchcock Canyon Rd (private easement), an access permit is required.
- Hikers, bicyclists and equestrians are not allowed on Hitchcock Rd. at any time.
- Bicycles must be transported on a permitted vehicle.
- Alternative access for hikers and equestrians is restricted via the Vasquez-Cougar Ridge trails within Garland Park.
- The information above applies ONLY to the shaded blue area to the left.

SHARING THE PUBLIC TRAILS

- Please be courteous to other trail users. Always yield to equestrians and allow other trail users to pass.
- Prevent injury to yourself and avoid damage to natural resources by using only designated trails.
- Please leash your dog or keep it under voice command at all times. Please understand that MPRPD defines the term "under immediate voice command of a person" to mean that the person must be within close visual contact of the dog. Clean up after your dog.

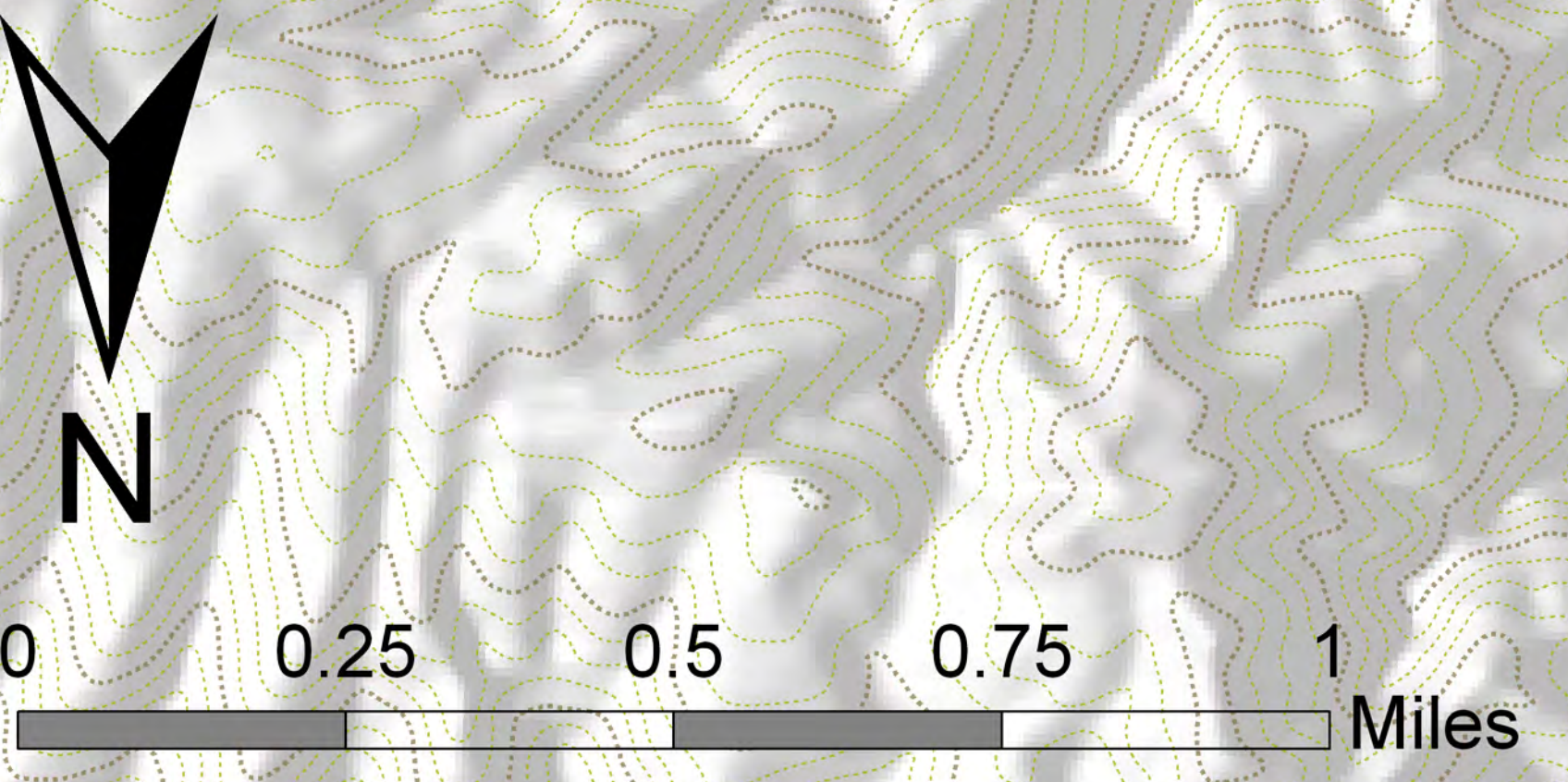
